February 20th, 2019 - Management of Wealth and Property The Judge also schedules the case for Court monitoring of the finances and property of the person in conservatorship as well as his or her welfare The law requires that an Inventory and Appraisal of all assets be filed within 90 days of the appointment of the conservator

September 4th, 2018 - Fees and Costs Before a Guardianship Is Established Attorney's fees for the alleged incapacitated person s court appointed attorney The court will appoint an attorney to represent the best interests of the alleged incapacitated person and the attorney will need to be paid for his or her services

1015 16 New York State Unified Court System

February 21st, 2019 - 6 A guardian committee or conservator may apply to the Presiding Justice for review and reconsideration of any fee on the ground of excessiveness Such application shall be in writing and shall be made within 20 days of service by the court examiner of the order directing payment of the fee from the estate

Guardian or Conservator Qualification

February 15th, 2019 - Guardian or Conservator Qualification Qualification for a guardian and conservator of an incapacitated person is before the Clerk of Circuit Court by appointment after the appropriate court order has been entered The person appointed has to give bond as required by the court order and take the appropriate oath prescribed by law
